We have notified all the companies with which you held appointments in North Carolina.

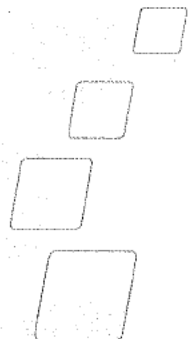
