2010 Resident Public Adjuster Fingerprint Submission Instructions

The following are the fingerprint submission requirements for North Carolina resident individual and business entity public adjuster license applicants pursuant to North Carolina G.S. 58-33A-15.

The fingerprint submission requirements are effective 7/1/2010 for all resident applicants for a public adjuster license in North Carolina and are set forth in North Carolina Administrative Code 11 NCAC 06A.0906.

Applicants for an individual public adjuster license must electronically submit their fingerprints for a state and federal criminal history background check following the instructions listed below.
Applicants for a business entity public adjuster license must electronically submit fingerprints for EACH key person of the business entity for a state and federal criminal history background check following the instructions listed below. A "key person" is considered an owner, partner, officer or director of the business entity, or member or manager of a limited liability company.

Please follow these steps:

- Print out BOTH the SBI Electronic Fingerprint Submission Release of Information form and the SBI Authority for Release of Information form posted on the Department's website under applications and forms for insurance licensing.
- 2. Fully complete and sign the SBI Authority for Release of Information form for each individual who is required to submit fingerprints.
- 3. Fingerprints must be submitted electronically for a criminal record history check by bringing the SBI Electronic Fingerprint Submission Release of Information form to a law enforcement agency authorized to submit fingerprints electronically to the State Bureau of Investigations (SBI) via live scan. If you are not aware of a local agency that submits live scan fingerprints, please refer to the NC county locations posted on the NCDOI website under applications and forms for insurance licensing. This form MUST be brought to the live scan location to be completed otherwise they will not be able to electronically submit the fingerprints. At the discretion of the live scan location, there may be a fee charged for providing this fingerprinting service. After the fingerprints are electronically scanned and the SBI Electronic Fingerprint Submission Release of Information form is certified by a law enforcement official at the live scan location, this form **MUST** be submitted within 30 days of submission of the public adjuster application.

4. REQUIRED SUBMISSIONS TO AGENT SERVICES DIVISION

Individual Public Adjusters Submit the required SBI forms to Agent Services Division via the following 2 preferred methods: Fax to 919-715-3794

A \$38.00 criminal record history check fee must be paid for each individual public adjuster applicant required to submit fingerprints. This fee should be paid during the NIPR electronic public adjuster application process. If this fee is not collected via NIPR and fingerprints are required, the fee must be submitted to the Agent Services Division along with the SBI forms. Mail forms and check or money order made payable to NC Department of Insurance to NCDOI-Agent Services Division, 1204 Mail Service Center, Raleigh, NC 27699-1204. Cash payments are not accepted.

Key Person(s) of Public Adjuster Business Entities - Submit the required SBI forms AND the \$38.00 criminal record history check fee for EACH key person of the public adjuster business entity to Agent Services Division. Mail forms and check or money order made payable to NC Department of Insurance to NCDOI-Agent Services Division, 1204 Mail Service Center, Raleigh, NC 27699-1204. Cash payments are not accepted.

A public adjuster application will not be considered complete until ALL of the above fingerprint requirements are submitted to the Agent Services Division.
