This matter was heard by the undersigned Hearing Officer, as designated by the Commissioner of Insurance pursuant to N.C.G.S. § 58-2-55, on April 20, 2005, in Room # 3099 of the Dobbs Building, located at 430 North Salisbury Street, Raleigh, Wake County, North Carolina. The Department of Insurance (hereinafter "the Department") was represented at the hearing by Diane G. Miller, Assistant Attorney General. Ondra Devone Richardson, (hereinafter "Richardson") did not appear and was not represented by counsel.

The Hearing Officer, after careful consideration and based upon the record as a whole, makes the following:

**FINDINGS OF FACT**

1. A Notice of Administrative Hearing was properly served on Richardson based upon the Affidavit of Service presented by the Department as Exhibit 2.
2. Richardson currently holds a license as a surety bondsman, issued by the North Carolina Department of Insurance pursuant to the provisions of Article 71, Chapter 58 of the General Statutes of North Carolina.
3. On or about December 6, 2001, Richardson was convicted of a felony, criminal non-support, in violation of Section 568.040 of the Missouri Revised Statutes.

Based upon the foregoing Findings of Fact, the Hearing Officer makes the following:

**CONCLUSIONS OF LAW**


1. Notice in this matter was timely and properly effected.
2. This matter is properly before the Commissioner of Insurance, and he has jurisdiction over the parties and the subject matter pursuant to Chapter 58 of the General Statutes of North Carolina.
3. Richardson's felony conviction, on or about December 6, 2001, is sufficient grounds to revoke his surety bondsman license under N.C.G.S. § 58-71-80(b) which provides that "[t]he Commissioner shall deny, revoke, or refuse to renew any license under this Article if the applicant or licensee is or has ever been convicted of a felony."

Based upon the foregoing Conclusions of Law, the Hearing Officer enters the following:

**ORDER**

Richardson's surety bondsman license is revoked.

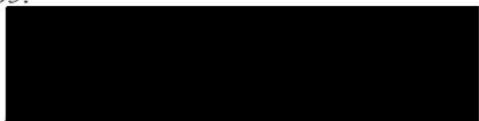
